China Pharmacopeia Delegation Receives IPEC Positions on Harmonization, GMP and Supply Chain Security

IPEC-Americas, along with representatives of other U.S.-based pharmaceutical, dietary-supplement, natural and herbal product associations, was an invited participant in a December 15 workshop

hosted by the U.S. Department of Commerce for a 25 person China Pharmacopeia delegation that also included an SFDA officer and drug control officials from Chinese provinces. Its purpose had two parts. The first was to provide China with information on U.S. regulation of dietary supplements and health food products. The second involved reports on the impact of globalization on the pharmaceutical industry and ongoing efforts for cooperation against counterfeit medicines and how they can be prevented.

IPEC's participant was past Chair David Schoneker of Colorcon who made two presentations during the all-day workshop. One was delivered as part of the dietary supplement portion and the second concerned "Control of Excipients for Use in Pharmaceutical Products" as a U.S. pharmaceutical industry participant. Here Mr. Schoneker explained IPEC and its purpose, our participation in the pharmacopeial harmonization process and the growing need in the global pharmaceutical industry for improved good manufacturing practices standards and supply chain security controls, particularly since so few regulations around the world "... describe appropriate GMP and technical controls for Excipients." Mr. Schoneker then went on to explain how IPEC guidance was developed to fill the different voids and concluded by saying:

- "It is CRITICAL only to use ingredients in drug formulations from high quality, reliable suppliers who meet appropriate GMPs and have good change notification programs in place
- Global Pharmacopeial Compliance must include requirements for appropriate GMP
- No longer is it acceptable to use ingredients from suppliers simply based on specification compliance and cost!!!"
